NOW THEREFORE BE IT RESOLVED THAT the Council of the City of Greater Sudbury has no objection to the granting an extension of the exemption to Noise By-law 92-13, to Falconbridge Limited and its contractors for operational requirements at the Nickel Rim South Project to July 31, 2006 subject to the conditions set out in Council Resolution 2004-643 remaining in effect.
BACKGROUND:
City Council at its meeting of 2004-01-29 passed Resolution 2004-48, which read in full as follows:
THAT this Council has no objection to the granting of an exemption to By-law 92-13, "BEING A BY-LAW TO PROHIBIT AND REGULATE NOISES IN THE TOWN OF NICKEL CENTRE", to Falconbridge Limited and its contractors for operational requirements at the Nickel Rim South Project to carry out intensive surface construction such as preparing the site, including moving the broken rock, drilling and excavating work for a four month period from February 1st, 2004 to and including May 30, 2004;
AND THAT approval of this exemption be subject to restricting blasting to the daylight hours only;
AND FURTHER THAT approval of this exemption be further subject to Falconbridge Limited and/or its contractors providing public notice of this construction activity prior to its commencement;
AND FURTHER THAT it is to be understood that this approval is given solely for the purpose of granting a noise exemption only and shall not be construed as an exemption or approval for any other purpose.
At the City Council meeting of 2004-05-13 an extension of the noise exemption was granted under Resolution 2004-258, which read in full as follows:
WHEREAS Council by Resolution 2004-48, 2004-01-29, granted Falconbridge Limited an exemption to Noise By-law 92-13 of the former Town of Nickel Centre for the period from February 1st, 2004 to and including May 30th, 2004;

NOW THEREFORE BE IT RESOLVED THAT the Council of the City of Greater Sudbury has no objection to the granting an extension of the exemption to Noise By-law 92-13, to Falconbridge Limited and its contractors for operational requirements at the Nickel Rim South Project to December 31, 2004 subject to the conditions set out in Council Resolution 2004-48 remaining in effect.

At the City Council meeting of 2004-12-16 an extension of the noise exemption was granted under Resolution 2004-643, which read in full as follows:

WHEREAS Council by Resolution 2004-258, 2004-05-13, granted Falconbridge Limited an extension to the exemption to Noise By-law 92-13 of the former Town of Nickel Centre for the period from May 30th, 2004 to and including December 31, 2004;

AND WHEREAS Falconbridge Limited has requested an extension of the exemption for operational requirements at the Nickel Rim South Project to carry out intensive surface construction such as preparing the site, including moving the broken rock, drilling and excavating work for a six month period from January 1, 2005 to and including July 31, 2005;

NOW THEREFORE BE IT RESOLVED THAT the Council of the City of Greater Sudbury has no objection to the granting an extension of the exemption to Noise By-law 92-13, to Falconbridge Limited and its contractors for operational requirements at the Nickel Rim South Project to July 31, 2005;

AND THAT approval of this exemption be subject to the following conditions: 1) Restricting blasting to the daylight hours only. 2) That approval of this exemption be further subject to Falconbridge Limited and/or its contractors providing public notice of this construction activity prior to its commencement. 3) It is to be understood that this approval is given solely for the purpose of granting a noise exemption only and shall not be construed as an exemption or approval for any other purpose.

A check of the By-law Office was conducted to determine if any noise complaints had been received and they indicated that no noise complaints regarding this project have been received.

RECOMMENDATION:

It is recommended that Council grant Falconbridge's request for an extension of the exemption to Noise By-law 92-13 of the former Town of Nickel Centre from August 1, 2005 to and including July 31, 2006 subject to the same terms and conditions as set out in Council Resolution 2004-643.

AND THAT approval of this exemption be subject to Aecon-Alarie Joint Venture providing notification to the area property owners of this construction activity with a copy to be provided to the City Clerk's Office for distribution.

BACKGROUND:

A letter dated July 12, 2005 was received from Mr. Ben Paille, Project Coordinator, Aecon-Alarie Joint Venture, requesting a noise by-law exemption for construction of the MTO project (Contract 2004-5004) located on Highway 69 South just east of Gladu Road, Sudbury. The exemption is for a crushing operation, which will run seven days a week, twenty-four hours per day until the end of August, 2005.

Mr. Paille advised that 160,000 tonnes of granular must be produced in order to continue the construction of the new "Four Lane Highway 69" and that a steady crushing operation is necessary in order to keep up with the progress of the construction.

He also stated, in his letter, that "in accordance with Special Provision No. 199F33M (construction for Contract 2004-5004), our crushing operations are not within the noise sensitive area limits of 500m from homes, businesses and cottages. This Special Provision does not specify any constraints against crushing".

A check of the By-law Office was conducted to determine if any noise complaints had been received. Mr. Bryan Gutjahr, Manager of By-law Enforcement Services, indicated that they have received one complaint regarding the noise from this activity.

Mr. Greg Clausen, City Engineer, had no concerns other than the neighbours be advised and that a foreman's name and contact number be provided.

Exception to noise by-law for crushing

Aecon-Alarie Joint Venture (AAJV) is requesting an exception to the noise by-law for construction of the MTO project located on Highway 69 South just East of Gladu Road. More specifically, the exception to the noise bylaw is for our 24 hours per day, 7 days a week crushing operation, which will continue until the end of August. Within this time frame, 160,000 tonnes of granular must be produced in order continue the construction of the new "Four Lane Highway 69". Our steady crushing operation is necessary in order to keep up with the progress of the job.

In accordance with Special Provision No. 199F33M (Construction Noise Constraints) for Contract No. 2004-5004, our crushing operations are not within the noise sensitive area limits of 500m from homes, businesses and cottages. This Special Provision does not specify any constraints against crushing. Please refer to attachment for a copy of this Special Provision.

Noise Sensitive Areas

This special provision covers the requirements for control of construction noise produced by the Contractor's operations. With the exception of any exemptions from municipal noise control bylaws that may be indicated elsewhere in the Contract, these requirements do not relieve the Contractor of other obligations imposed by statute or by municipal bylaw.

Noise constraints in noise sensitive areas are as follows:

Noise Sensitive Area Limits

Within the contract limit and within 500 m of homes, businesses and cottages, and at all MTO and crown sources listed on the aggregate sources list.

Constraint	Constraint Details						
Equipment Maintenance	Equipment shall be maintained in an operating condition that prevents unnecessary noise, including but not limited to non-defective muffler systems, properly secured components, and the lubrication of moving parts.

Background:

The firm Nicholls Yallowega Bélanger Architects/Architectes (NYBAA) have been the consultants of record for the Lionel Lalonde Centre over the last several years and have the experience and expertise to complete the project approved by Council on May 26, 2005. NYBAA were the original architects of the school and have staff members who worked on the original building. The firm has been involved in all subsequent renovations to the facility (boxing, dormitories, fitness centre, classrooms and workshops,...).

The Purchasing By-Law requires Council's approval for sole sourcing of Consultants. The Manager of Assets in consultation with the Manager of Supplies and Services/Purchasing Agent recommends the sole sourcing of this project to NYBAA, based on their experience, records and expertise with this building. This would also allow the project to begin this summer rather than late Fall or early Spring to ensure that substantial completion is achieved by the Fall of 2006.

The Supplies and Services Section will prepare the contract documents and the Assets Section will co-ordinate the construction project with NYBBAA.
