

Title: 2008 Miscellaneous User Fees

Date: January 23, 2008



BACKGROUND

In accordance with the current Miscellaneous User Fee Bylaw, the 2008 rates are to be increased by the greater of 3% and the September 2007 Stats Can Consumer Price Index (C.P.I.) for all items, which was 2.5%.

Most fee increases were in effect on January 1, 2008. However, some fees follow the playing season such as ice rentals and play fields, and will reflect the increase at the start of the season as opposed to the calendar year.

As of January 1, 2008 the Goods & Services Tax (GST) has been reduced from 6% to 5%. Fees where GST is applicable have been revised accordingly.

In most cases, the 2008 User Fees have been rounded to the closest \$.25, \$1.00 or \$10.00, depending on the value of the service provided.

A number of new fees have been introduced for 2008:

Cemetery	Glass Niche Adornment Opening	\$24.76 plus GST
Cemetery	Genealogical Searches over 4 names	\$49.52 plus GST
Cemetery	Title Search	\$150.00 plus GST
Sign Fees	Removal of Sign	greater of \$100 or actual recovery fee
Sign Fees	Storage of Removed Signs	\$10 / day

As well, the Cemetery has elected to leave fees for Mausoleum Crypts at their 2007 levels.

A bound copy of the Miscellaneous User Fee Bylaw will be circulated to Council in the near future.
