5. Report dated 2005-03-04 from the Acting CFO/Treasurer regarding Area Rating - Fire Services.

(FOR INFORMATION ONLY)

(The deployment strategy for firefighters to various areas of the City has been evolving over the last 18 months. Some areas that were receiving service from only volunteer stations are now being serviced by both a career and a volunteer-manned fire station. In addition, each response also calls for the aerial or rescue vehicle (housed downtown) to attend. For this reason, the area rating scenario has to be re-evaluated. However, given the complexity of determining the new boundaries and extracting the accurate assessment, this will be quite an onerous task which will take months to complete. For this reason, for 2005, the area rating for fire services will continue to correspond to the old municipal boundaries, with base costs adjusted to include staffing for the aerial and rescue vehicles. Area rating service levels and boundary issues will continue to be reviewed for further adjustment in 2006 and beyond.)
