For 2007 the City of Greater Sudbury's share of \$25,000 can be absorbed within the existing Social Services budget. For 2008 the one time allocation of the City of Greater Sudbury's share of \$25,000 will be budgeted for within the 2008 Social Services budget. The Ministry of Community and Social Services have committed to funding \$25,000 in each of the 2007 and 2008 years for these initiatives. Background:

The Social Planning Council (SPC) of Sudbury is a not for profit community organization that is engaged in building and strengthening the community through its activities in research, public education, community development, social policy and advocacy. The SPC receives funding from federal, provincial and municipal governments, from charitable organizations (Laidlaw Foundation, United Way/Centraide etc.), donations, sponsorships and memberships/dues as well as generating revenue through fee for service work.

The SPC has been provided annual base funding from the Regional Municipality of Sudbury and subsequently the City of Greater Sudbury. Current base funding is in the amount of \$50,000. This base funding has enabled the SPC to leverage an additional \$450,000 per year in project and partnership funding. The base funding contribution provides support to the overall infrastructure of the SPC, which has supported the following work:

- Homelessness/Housing research and participation on the Community Solutions Team and Homelessness Advisory Committee
- The Homeless Individual and Family Information System (HIFIS) data collection
- Support to the Best Start Network including research and evaluation, developing community partnerships and facilitating the development of the Intersectoral Planning Report
- Support and development of information referral services and the mysudbury! Portal
- Selected as the lead agency for the civic engagement/social capital pillar of the Healthy Community Strategy.

In 2004, funding in the amount of \$50,000 from the City of Greater Sudbury had enabled further initiatives such as: the development of a Human Services Strategy for the City's Official Plan, the development of a framework for the Affordable Housing Strategy and the development of a framework for Civic Engagement research and action plans.

For 2007 and 2008, the Ministry of Community and Social Services will provide one-time co-funding of the additional \$50,000 contribution to the SPC.

Recommendation:

It is recommended that for 2007 and 2008 that the SPC receive an additional \$50,000 dollars of funding for:

- 1. The development and implementation of a work plan for the civic engagement/social capital pillar of the Healthy Community Strategy;
- 2. The development of a poverty reduction strategy with community partners; and
- 3. The development and implementation of social capital initiatives related to sustainable employment opportunities for those living below the poverty line.

This recommendation has been consistent with past practices as the City of Greater Sudbury has funded the Social Planning Council as projects were undertaken.

The provincial government's *Clean Water Act*, 2006 came into effect on July 3, 2007 with the approval of the first phase of the accompanying regulations. The Act mandates that a broad-based multi-sectoral Source Protection Committee be created. This Committee will develop the Terms of Reference, an Assessment Report and a Source Protection Plan to protect current and future sources of municipal drinking water.

O.Reg. 288/07 specifies that the Greater Sudbury Source Protection Committee will consist of 9 members plus a Chair, with 1/3 of the members being municipal representatives. The City of Greater Sudbury is the only municipality that has municipal residential drinking water systems with the Greater Sudbury Source Protection Area, therefore three (3) members are to be appointed from this municipality.

When the Clean Water Act came into effect, the Nickel District Conservation Authority automatically became the Greater Sudbury Source Protection Authority under this Act. The Source Protection Authority has four City Councillors and three non-elected members. The Authority is asking the City of Greater Sudbury to name three (3) people to sit on the Source Protection Committee. The Authority suggests that the three positions be filled by senior staff with technical expertise in areas such as drinking water systems, land use planning, storm water management or other areas that could affect the quality of groundwater and surface water. One of the most important functions of the committee will be to develop practical strategies that can be successfully implemented to protect local sources of drinking water.



The provincial government's *Clean Water Act*, 2006 came into effect on July 3, 2007 with the approval of the first phase of the accompanying regulations. The Act mandates that a broad-based multi-sectoral Source Protection Committee be created. This Committee will develop the Terms of Reference, an Assessment Report and a Source Protection Plan to protect current and future sources of municipal drinking water.

O. Reg. 288/07 specifies that the Greater Sudbury Source Protection Committee will consist of 9 members plus a Chair, with 1/3 of the members being municipal representatives. The City of Greater Sudbury is the only municipality that has municipal residential drinking water systems within the Greater Sudbury Source Protection Area, therefore **three** (3) **members** are to be appointed from this municipality. A map of the planning area is attached.

When the *Clean Water Act* came into effect, the Nickel District Conservation Authority automatically became the Greater Sudbury Source Protection Authority under this Act. The Source Protection Authority has four City Councillors and three non-elected members. The Authority is asking the City of Greater Sudbury to name three (3) people to sit on the Source Protection Committee. The Authority suggests that the three positions be filled by senior staff with technical expertise in areas such as drinking water systems, land use planning, storm water management or other areas that could affect the quality of groundwater and surface water. One of the most important functions of the committee will be to develop practical strategies that can be successfully implemented to protect local sources of drinking water.

Proposed Committee Composition

The proposed committee composition is under public review from August 3 to September 3, 2007. O. Reg. 288/07 stipulates that 1/3 of Source Protection Committees be from the municipal sector, 1/3 from economic sectors and 1/3 from other interests. Other interests refers to interests other than municipal and economic, such as environmental, health and other interests of the general public. The committee should reflect the stakeholders of the planning area, especially those that most affect or are most affected by municipal drinking water sources; current sources are Ramsey Lake, the Vermilion River, the Wanapitei River and 22 municipal groundwater wells. The proposed committee composition is:

In addition to these members, there will also be seats available for local First Nations, the Sudbury & District Health Unit, the Ministry of the Environment and the Source Protection Authority.

The Source Protection Authority will be working with sector members to solicit applications for the "Economic Sector" and "Other Interests", as well as posting ads in local newspapers and on the Internet.

Summary of Obligations of a Source Protection Committee Member

- Contribute positively to the production of a Terms of Reference, Assessment Report and Source Protection Plan
- Attend monthly meetings of the Committee (these may be day-time meetings)
- Review and understand scientific technical reports and source protection concepts and science
- Make a 3-5 year commitment to participate as a Committee member
- Participate at public meetings, attend public information sessions and participate in public consultation forums
- Review material provided in advance of a meeting when that material has been provided in a timely fashion
- Be prepared to start in the fall of 2007
- Demonstrate an ability to weigh different points of view
- Exhibit solid problem-solving, analytical, communication and organizational skills
- Hold relevant knowledge of watersheds, land uses, and local water related issues
- Work with others collaboratively and contribute positively to group dynamics
- Act as a liaison to bring forward concerns, issues, knowledge and experience from their sector to the Committee and assist in communicating the Committee's work back to their sector
- Make decisions at the Committee table

- Attend training sessions which will be provided, including: legislative responsibilities of the Committee; procedures developed by the Province of Ontario for Drinking Water Source Protection Planning; and technical training
- Respect confidential information and abide by the process in place to safeguard confidential information, such as the *Municipal Freedom of Information and Protection of Privacy Act* (MFIPPA)
- Travel around the source protection area

O. Reg. 288/07 provides municipalities two months to pass a council resolution that provides a list of names for municipal representatives to the Source Protection Authority. The Authority is requesting that you provide these names, approved by council, by **November 3, 2007**.

Please submit the three names for the Source Protection Committee in writing to the Source Protection Authority c/o the Nickel District Conservation Authority at 200 Brady Street, Tom Davies Square.

Thank you for your cooperation with this new initiative. We look forward to strengthening our partnership with the City of Greater Sudbury in protecting our sources of municipal drinking water.
