Background

The Canadian Urban Transit Association (CUTA) was originally founded in Montréal on December 20, 1904 as the Canadian Electric Railway Association, and, in response to a decline of electrically operated street railways, the name was changed to the Canadian Transit Association in 1932. The present name was adopted at the Annual General Meeting in 1973 and incorporated accordingly.

Originally restricted to transit system members, CUTA's membership now includes government agencies, manufacturers and suppliers of products and services, trade unions, related association and individuals.

The CUTA Transit Board Committee held its Inaugural Meeting on May 29th, 2005 in Gatineau, Quebec. Attached hereto as Schedule "A" is a copy of the Membership List and at Schedule "B" is a copy of the Terms of Reference for the Transit Board Committee.

There are 2 meetings annually - the annual conference in June, and the fall conference in November. The cost of travel to these 2 conferences are to be borne by the member, that is, Councillor Dupuis.

GOALS

- Identify current and emerging municipal issues of concern to the industry and provide assistance in resolving them.
- Raise awareness and promote the use of transit best practices throughout the municipal sector.
- Assure ongoing liaison with FCM and provincial municipal associations.
- Enhance the profile and voice of transit among municipal decision-makers nationwide, and use this profile in advocating for transit at the provincial and federal levels.

OBJECTIVES

- Advise staff and other committees on advocacy strategies.
- Identify and assist CUTA in researching policy-related issues.
- Communicate with members and other organizations to keep abreast of relevant issues.
- Identify topics for CUTA's conferences and workshops.

MEMBERSHIP / REPORTING RELATIONSHIP

- The committee should have balanced representation in terms of system size and geography. There should be at least one member from each province/territory, if possible.

- A CUTA employee will act as staff liaison and will provide support to the Committee Chair and Vice-Chairs. In the beginning, this will be the President & CEO.
