



As you may recall, the Committee has already dealt with this matter at the May 5, 2008 meeting where, following the recommendations indicated in the "Request for Recommendation" report (a copy of which is attached), the Committee agreed with the naming of the unnamed laneway east of Eva Avenue. The Committee then recommended staff contact the affected property owners in order to determine their comments on the proposed name.

Shortly after letters were sent to the homeowners, Mr. Doug Hubley, one of the property owners, who initially requested that the unnamed laneway be named, notified the City that all three property owners approved the naming of the laneway as Evita Lane.

Therefore, it is recommended that this unnamed laneway be named Evita Lane, and that the three affected houses be given numbers equal to their existing house numbers on Eva Avenue.

In 2006, the City received a request from Mr. Doug Hubley of 472 Eva Avenue. Mr. Hubley indicated that the only access to his house is through an unnamed laneway, even though his house address is solely that of Eva Avenue.

Mr. Hubley indicated that there were instances when emergency services were required, and the ambulance, police and fire services were not able to find the laneway in question. He was requesting that this laneway be named.


It can be noted that Eva Avenue is in an older section of town and rises fairly substantially from the CNR tracks going north. Eva Avenue breaks into two parts, with a westerly section rising further up and providing access to houses on the west side of Eva Avenue. The lower portion of the fork provides access to some of the houses on the east side of Eva Avenue.


However, there are three houses which, though nominally on Eva Avenue, do not have any access to the constructed roadway at all, and take their access entirely from the laneway to the east of Eva Avenue. At the corner of Eva and Jean is a sign indicating "To 472-488 Eva". In accordance with Council Policy, a laneway that provides the only access to a property should be named. The City's Fire Services Section have looked into this issue, and feel that the naming would be of assistance. There are access and pumping problems that might be encountered in this area, but these are unrelated to the naming issue.

It is the staff recommendation that this laneway be named Evita Lane, and that the three effected houses be given numbers equal to their existing house numbers on Eva Avenue. The name was chosen from a preliminary list of names approved in principle by the Committee earlier. The Committee may wish to consider whether it should continue the naming of this laneway south of Jean Street as well as far as the CNR tracks. This would not affect any properties, but might be of some assistance in the future. The City's Emergency Services have indicated that they would like to see every laneway in the City named to assist in way finding, and the City's Cartography staff have been working on mapping to include placeholders for such naming. It is recommended that the Committee give direction on this issue.

It is also recommended that the Committee have a discussion in general terms about how names are to be selected when requests come forward. Should the requester be asked to submit a name? Should the requester be asked to seek the concurrence of property owners affected by the name? Should the City suggest names prior to any action being taken, and should this be circulated to the affected property owners? Should the matter merely come forward through public advertisements once the Committee has dealt with the issue? Should the Committee do numbering changes at the same time as it does naming changes? (This last item is strongly recommended.)

If the Committee can have this sort of a discussion, it will be of some assistance to staff in drafting a series of procedures to be presented to the Committee to deal with the many requests that have been made.

# Division Review

#### **BACKGROUND:**

Enclosed please find a letter from the Administrative Director of the Centre franco-ontarien de folklore along with a translated version of this letter. The Centre franco-ontarien de folklore is asking that the south portion of Dollard Street be renamed in honour of Father Germain Lemieux.

As the attached map shows, Dollard Street is broken into two sections at the current time. There is a subdivision that has been established between these two sections, so that Dollard Street can never be joined up in the future. As Ms. Gervais indicates, this is confusing, and is on a list of streets called "broken streets", which the Committee will be asked to address.


It is recommended that the Committee approve the name as suggested, and hold a public hearing prior to passing the By-law. The proposed name, rue Germain-Lemieux Street, is not in conflict with any other existing name.

This roadway has been surveyed and is in the City's name. The are no other Dollard Streets within the City of Greater Sudbury.

The proposed By-law would affect the southern portion of Dollard Street which consists of approximately 20 residences and the Centre franco-ontario de folklore. There are no numbering problems with the street.

The northern section with the access off of Madison Avenue consists of approximately 47 residences.

Given that a number of residences would be involved with this name change, it is recommended that Council hold a public hearing on this topic and that notice be given specifically to the residences affected by the proposed change.

Dollard Street is divided in two and this is sometimes confusing. We would be very pleased to have our section of street renamed.

Born in 1914 at Cap-Chat (Gaspé county) in Quebec, Father Germain Lemieux moved to Sudbury in 1941. He taught at Collège Sacré-Coeur, University of Sudbury and Laurentian University. Since 1948, Father Lemieux has been collecting songs and tales in order to preserve oral Franco-Ontarian traditions. In 1972, he founded the Franco-Ontarian Folklore Centre. Please find attached a list of his publications as well as prizes and awards he has received. Father Germain Lemieux now lives at the Jesuit Retirement Home in Saint-Jerome, Quebec.

# Division Review

#### **BACKGROUND:**

A request was received in 2005 from Mr. David Bimm, the proprietor of North Star Recreation outlining problems associated with the portion of Armstrong Street where he was located.

As the attached map indicates, this portion of Armstrong Street is highly confusing, and it is recommenced that it be renamed. At this time, the property referred to by Mr. Bimm is the only development on the street. The others are vacant lots, and so it makes sense to make the change at this time. The property occupied by Mr. Bimm is now vacant and being used for outdoor storage. The property is for rent, and so no businesses will be disturbed by this change, and it is recommended that this occur before other development on the street happens. Mr. Bimm himself has moved away to another location, but when consulted on the matter, still felt it appropriate that the matter proceed, and was glad to see that it was progressing.

It can be borne in mind that there are already three Armstrong Streets in Greater Sudbury and a recommendation will be brought forward for the elimination of this duplication at a later date. Even if the committee chooses to rename the Armstrong Street at this location, the portion of the street by Mr. Bimm's business should have a separate name in any event.

It is not recommended that this street be named North Star Street as originally suggested. A draft Policy for Council's consideration indicates that it would be inappropriate to name streets for businesses given that businesses may relocate from time to time or other problems be encountered. The name rue Céline Street is recommenced.

This portion of Armstrong Street was defined by plan of survey and is in the City's name.

It is recommended that the necessary By-law be passed changing the name. It is not recommended that a public hearing be held given that only one property owner is affected, and that being a vacant property. We have contacted the property owner, who has no objections.

North Star Recreation 2280 Armstrong St. Sudbury, ON

Dear Mr. Craig and Ms. Caldarelli,

I am seeking your assisting in correcting a problem with street signage that is having a negative impact on my new business.

Three weeks ago, I opened my recreational engine repair facility on Armstrong St. in the south end of the city. The location is ideal. My enterprise sits on an accessible property near one of the busiest access routes into the city. Located in the only building of any description on this extension of Armstrong St., one would assume that it would be easy to find. This is not the case, however.

The problem lies in the confusing manner in which Armstrong St. is named.

Armstrong St. extends from Regent St. in a northerly direction into Lo-Ellen Park past Muriel St. and onto to Hunter St. The confusion is caused by the fact that, as people drive onto Armstrong St., they do not realize that Armstrong St also extends at a hard 45 degree angle to the right. They anticipate that one street meeting another at perpendicular angle would have its own name.

As people access Armstrong St. from Regent St., their natural inclination is to seek an address along the main part of Armstrong St. as homes and other businesses are plainly in sight ahead. My business, however, sits on the branch of Armstrong and is somewhat obscured by trees and rocks. My clients have traveled the entire length of Armstrong St. before returning and looking for my business on the extension of the street.

As a result, there is a significant loss of business arising from confused and frustrated clients.

#### Consider the following:

Purolator drivers who deliver parts and other materials have not been able to find my shop. You can imagine the problems this poses to an operation that prides itself in efficient, timely and superior service;

Last week, a resident of 2280 Muriel St. was kind enough to drop

off a stack of mail that had been intended for my address (2280 Armstrong St.) and was mistakenly delivered to his home. In that package of mail was a \$1,200 cheque;

Last Friday, I ordered pizza for staff working overtime from the Pizza Hut not far from here. When the deliver person could not locate 2280 Armstrong St., the individual thought that it should be delivered to the other Armstrong St (there are three in Sudbury) - the one in Garson.

If couriers, postal workers and others in the conveyance trade have difficulty finding my business, then I shudder to think of the potential consequences if emergency fire and/or ambulance services experience the same problem.

The problem is self-evident in the map of the area that I have attached. This map is typical of way the maps show Armstrong St. One can only assume that the extension of Armstrong St. extending to Cam St. has no name.

I am well aware of the dilemma the city faces in dealing with street name duplication brought about by amalgamation. In my view (and in yours too, I assume) renaming many streets is inevitable.

Fortunately, the solution in this case is simple, inexpensive and can be immediate. My suggestion would be to rename it "North Star St." No other street in Greater Sudbury currently bears that name. Fortunately for the city, achieving consensus for changing the name should not be an issue as mine is the only active business (there are no residents) on the street.

Ultimately, whatever new name is selected is irrelevant to me as long as the duplication is eliminated as soon as possible.

I hope that you can understand my issue. The current situation is untenable as the lack of clarity is affecting the profitability of my business. Currently, my business cards list the Armstrong St. address but I would gladly undertake the expense of reprinting new ones if it meant alleviating the confusion induced by the current state of affairs.

I urgently seek your assistance in rectifying this serious matter. I can be reached daily if you require further clarification



#### **BACKGROUND:**

The City has been requested to name a laneway, and a copy of the request is attached. A map showing the location of the laneway is also attached. The property is in the City's name.

The name requested, ruelle St. Germain Lane, does not conflict with any existing name and is in accordance with the City's policy.

It has been the City's policy not to name laneways unless they provide the exclusive access to properties, however, it is recommended that this policy be changed following requests from the Police and Emergency Services. They have requested that the City provide names to all lanes as it would be of assistance to them for the provision of emergency services.

No public notice is required to name this laneway, and so it is recommended that the City pass the necessary By-Law to name the lane as requested.

I was wondering if a light could be installed in the lane off Brebeuf st, the lane is between 311 and 305 Brebeuf Ave. I have notice other lanes that have lights so it would be nice if the city could install at least one light in the lane because it's very dark at night and there are many vehicles using it. I was born in this house at 305 Brebeuf Ave ,it was the first house to be built on this street. Would it be possible to name the lane ST.Germain lane. I think it would be appropriate to erect a sign with the ST.Germain name. There are lots of lanes in Sudbury that have names. This is not too much to ask. 





## Division Review

#### **BACKGROUND:**

The City has received a number of requests in the form of letters and petitions requesting naming of a private road. This item has been an issue relating to difficulty experienced by an ambulance in finding one of the homes. A copy of the petition and an article from Northern Life is attached. The City established a sign at the intersection of this roadway and Tilton Lake Road showing the house numbers for easier identification, and the private road naming should be done as requested.

The naming of private roads is a power given to municipalities under the *Municipal Act*, 2001. It does not involve an obligation on behalf of the City to maintain or otherwise deal with the road.

This is a private road providing access to these six locations and no others and the name requested, chemin Lohi Lake Road, is in accordance with the City's policy on road naming.

It is required that before a By-Law is passed, Notice must be given for the naming of a private road, so it is recommended that Notice be given, and if no objections are received, that the necessary By-Law be passed.

#### Petition # 1

City of Greater Sudbury Legal Department Attention: Mr. Ron Swiddle City Solicitor

We, the undersigned residents of Lohi Lake, petition the City of Greater Sudbury to erect a city street sign (Lohi Lake Road) and a "No Exit" sign at the intersection of Tilton Lake Road and our common right of way. There are six permanent residences on Lohi Lake sharing this common right of way (measuring approximately 1/4 km) from Tilton Lake Road. None of our residences are visible from Tilton Lake Road and finding any one of them could be unclear to emergency attendants. This is, obviously, a health and safety issue. In addition, this also causes confusion for other service providers (deliveries, repairs, Sudbury Handi Transit, taxis, etc.) and visitors.

We are not expecting the City to clean nor maintain our "common right of way" road. But we, however, want to be recognized as any other City of Greater Sudbury tax paying residents by having a city street sign and "No Exit" sign to indicate to the public where we reside.


