Background:

A letter dated December 11, 2006 was received from Mr. M. Sinclair, Hinds & Sinclair, on behalf of INCO Limited requesting an extension of the exemption to Noise By-law 93-424 of the former Town of Walden for the site preparation and construction activities for the Totten Mine project, which is located on the south side of MR 4 (Fairbank Lake Road) in the former townsite of Worthington, for the period of January 1, 2007 to December 31, 2007.

At the September 27, 2006 meeting of Council, Resolution 2006-895 was passed:

"THAT this Council has no objection to the granting of an exemption to Noise By-law 93-424 of the former Town of Walden to INCO Limited for the site preparation and construction activities of the Totten Mine Project, located on the south side of MR 4 (Fairbank Lake Road), in the former townsite of Worthington;

AND THAT exemption to Noise By-law 93-424 of the former Town of Walden be granted for the following dates and times: September 29, 2006 to December 31, 2006 from the hours of 8:00 p.m. of any day and 7:00 a.m. of the next following day;

AND THAT approval of this exemption be subject to INCO Limited providing public notice of this construction activity."

We make reference to the noise exemption granted to Inco Limited by Resolution 2006-894 with respect to the re-activation presently being undertaken at Totten Mine, in the geographic Township of Drury, on the Fairbank Lake Road (Municipal Road No. 4). The exemption requested by Inco and granted by the City was for the period September 29, 2006 to December 31, 2006.

We are presently advised that the construction work as planned is going well and the present phase should be finishing towards the end of April, 2007. The underground rehabilitation work is scheduled to start at the beginning of April, 2007.

On this basis we have been requested by Inco to request a further exemption to Noise By-Law 93,424 of the former Town of Walden for the period January 1, 2007 to December 31, 2007.

Executive Summary:

The purpose of this report is to appoint additional Members of Council to various local boards and corporations for the term of Council (2006 - 2010).

All appointments will be confirmed by resolution of Council. Reports will be presented for additional Boards, Committees and Advisory Panels in the new year.

Background:

1. SUDBURY AIRPORT COMMUNITY DEVELOPMENT CORPORATION

The City is required to appoint two Councillors to this Board.

2. CITY OF GREATER SUDBURY COMMUNITY DEVELOPMENT CORPORATION (GSDC)

The City is required to appoint three Councillors to this Board or as many as six. For the last term of Council, only three were appointed following a request to this effect from the Board itself.

Selection:

The selection of these positions are to be conducted in accordance with Section 37 of the Procedure By-law. Section 37 of the Procedure By-law is attached to the report regarding the appointment of Deputy Mayors.

Council's procedure requires that in the event more candidates are nominated for the required position(s), then a roll call vote of Members of Council shall be held.

In the event a member of Council requests a vote by paper ballots a supply of ballots has been prepared.

Where all Members of Council are in attendance, <u>seven (7) votes are required to fill each vacancy</u>. <u>Each Member is entitled to one (1) vote</u> for each of the Chair's and Vice-Chair's positions.

Where no applicant receives the majority required for appointment and where two or more applicants are tied with the <u>least number of votes</u>, a special roll call vote shall be taken to decide which of the tied applicants with the least number of votes <u>shall be dropped from the list of names to be voted on in the next vote</u>.

In the event of an equality of votes, then the successful candidate is to be determined by lot conducted by the Clerk.

It is always in order for a Member of Council to nominate themselves and to vote for themselves. Under *Robert's Rules of Order* a nomination does not need a second.

Once the successful candidates have been selected, then a resolution will be introduced confirming the appointment of the successful candidates.
