## Background:

City Council at their meeting of May 24, 2006 passed a resolution awarding Contract 2006-21, Lasalle Boulevard Widening, Atlee to Barrydowne to Interpaving Limited. To avoid significant traffic delays and congestion that would result if the work were undertaken during the day, Council agreed that the work be done during the evening - 7 p.m. to 7 a.m. As a follow-up to the award of the Lasalle Boulevard Widening Contract (Night Work), an exemption to the Noise By-law is required from June 2005 to mid-September 2006.

Complaints have been received from area residents with respect to the noise during the evening. The majority of these complaints were received at the start of the project in June. Two area residents are advising of noise during the evening. The Director Roads and Transportation has contacted the contractor and requested that the noise levels be kept to a minimum and the contractor has agreed to schedule his work to reduce noise levels after 12 p.m.

Tenders for Contract 2006-21, Lasalle Blvd. (MR 71) Widening, Attlee Avenue to Barrydowne Road were opened at the Tender Opening Committee meeting of April 26, 2006 and the following are the results:

The lowest tender for Contract 2006-21, Lasalle Blvd. (MR 71) Widening, Attlee Avenue to Barrydowne Road, meeting all contract specifications was submitted by Interpaving Limited in the amount of \$1,949,193.80 (standard).

This project requires a further \$175,000 for utility relocations and \$100,000 for property acquisition. As outlined in the following paragraph, there will be a recovery of \$101,700 from the shopping centre. Based on the lowest tender of \$1,949,193.80 (excluding GST \$1,821,676.45), and including utilities and property the project has a total cost of \$2,096,700. Subtracting the contribution from the mall, and allocating the watermain work to the Water Capital Envelope, leaves a net cost of \$1.906 million. The funding for the project when originally budgeted for 2006 was \$1.6 million which leaves an estimated funding shortfall of \$306,000.

Contract 2006-21 will result in improvements along a section of Lasalle Boulevard from Attlee Avenue to Barrydowne Road. The work has been delayed for two years because of redevelopment work on the New Sudbury Shopping Centre. The work ties into the development with improvements at the entrances to the shopping centre, that include a new right-turn lane at the Roy Street entrance. This work is funded from a \$101,700 contribution from the shopping centre. The project includes some minor watermain work in the amount of \$89,000.

The construction tenders have come in significantly higher than estimated. The main reason for the price increase has been attributed to higher oil prices. This increase can be seen by the more than fifteen percent (15%) increase in asphalt prices over the last year and similar increase in granular materials. These components comprise the largest part of the construction project.

Title: Award of Contract 2006-21 Lasalle Blvd. (MR 71) Widening

Date: May 19, 2006

This project was tendered in two ways; one being as a standard contract where work would be done during the daylight hours (7:00 a.m. to 7:00 p.m.) and an alternate where the contractor would be restricted to working night time hours (7:00 p.m. to 7:00 a.m.). This alternative was considered as staff recognized the significant delays and congestion that will result in daytime work.

The extra cost to perform the work at night, based on the lowest tender would be an additionall \$158,271 (excluding GST), resulting in a total shortfall of close to \$465,000. Although this will increase the funding shortfall, staff would support the recommendation of night construction to minimize daytime delays.

Council can consider the following options to address the funding shortfall.

#### Option 1

The funding could be taken from the 2006 Capital Road Program since some projects will not be completed this year. At the end of the year any shortfall in funding would be included in the 2007 Capital Road Program.

#### Option 2

The funding could be taken directly from the 2007 Capital Road Program leaving the 2006 Program as approved.
