Item 4 Lake Water Quality Report dated 2006-01-30 from the General Manager of Growth & Development regarding Lake Water Quality Program 2005 Annual Report was received.

A bound copy of the Lake Water Quality Program 2005 Annual Report was circulated under separate cover.

Ms. Lana Haslam, Co-ordinator of Lake Water Quality Program, gave an electronic presentation which outlined program activities.

She outlined activities which contributes to shoreline re-vegetation, lake clean ups and water sampling, such as the spring phosphorus sampling which assesses the health of lakes within the City of Greater Sudbury, and the establishment of the Lake Stewardship Assistance Grant Program which was endorsed by Council.

Ms. Haslam also indicated that with the creation of the Community Water Stewardship Program, they have been able to conduct two hundred fourteen dock-to-dock visits, forty-four in-depth shoreline visits on eighteen lakes, and distribute three hundred sixteen information packages.

She advised that for 2006 they are proposing to bring forward a Lake Report Card, a demonstration site of a natural shoreline and a Shoreline Home Visit

Ms. Tina McCaffrey, Supervisor of Land Reclamation, provided Council with an electronic presentation. She advised that in 2005 over 200,000 trees were planted and 21.3ha of land was limed, with a total of over eight million trees planted and an area of 3,367ha limed, since the inception of the program. Their focus areas are watershed improvements, and in urban areas, tree canopy cover and schoolyard greening.

She indicated that various funding partners help in areas such as labour, cash, and materials/in-kind. They have received funding since 1978 from partners such as INCO, Falconbridge Ltd., Municipal, Provincial, Federal, etc.

Ms. McCaffrey indicated that for 2006, their focus will be on the Ramsey Lake Watershed, liming activities, increase diversity, and city beautification.
