Item 4 Sudbury Wolves

Mayor Rodriguez and the Members of Council recognized the Sudbury Wolves as the Eastern Conference Champs and the remarkable season they had. Mr. Mike Foligno, Head Coach and General Manager, Mr. Bob Jones, Assistant Coach, and Mr. Nick Foligno, Sudbury Wolves #16, expressed their appreciation to Council and the City of Greater Sudbury for their support.

Mr. (Mike) Foligno stated that "the city's support has been incredible and a driving force for the hockey club and we are proud to be a part of this community".

Mayor Rodriguez presented a framed photograph in recognition of the hockey club's tremendous achievements. The photo was taken at the Sudbury Community Arena two days after the completion of the 2007 OHL Finals. The image is symbolic of the Wolves' colourful and hard fought playoff run.

Mr. Rick Millette, Director, Service Canada and Ms. Nancy Dube, Chair of the Community Advisory Panel on Homelessness, presented an award and congratulated Mr. Harold Duff, Ms. Mary Murdoch and Members of Council, on the tremendous job in providing a safe and secure community for the homeless in the City of Greater Sudbury.

Item 6 NDCA Drinking Water Source Protection Program Update Mr. Bob Rogers, Chair of the Nickel District Conservation Authority Board of Directors, introduced Ms. Judy Sewell, Drinking Water Source Protection Coordinator, NDCA, who provided Council with an electronic presentation entitled "Drinking Water Source Protection".

She provided the roles and responsibilities of the Ministry of the Environment (lead), Ministry of Natural Resources (support), the Conservation Authorities [coordinate Source Water Protection (SWP) Program], and the municipalities (participate in developing & implementing plans). She stated that the SWP Program was developed to protect the quality and quantity of drinking water.

Ms. Sewell advised that the SWP area covers approximately 9,000 km² and three watersheds, Wanapitei, Vermilion, and Whitefish Rivers. She noted that the Clean Water Act does not cover privately owned water sources. She outlined the drinking water sources within the City of Greater Sudbury and how the Drinking Water Protection (DWP) Program will be applied and what mechanisms are in place to implement it.

She stated that the Source Protection Plan determines where the water comes from, identifies any threats, and develops strategies to reduce or remove threats. She indicated that a Source Protection Committee will be formed in September and that the municipality will be involved with the development and implementation of the plan.

Ms. Sewell stated that background studies are to be completed, the plan needs to be developed, implemented, monitored, amended, administered, and renewed. She concluded by stating that tight timelines to obtain a Chair and establish a Committee are issues they are facing as well as long term funding.

Item 7 Crime Stoppers Program Update Item 7 was pulled from the agenda and not dealt with.

Item 8
International Charter
for Walking

Mr. Bob Rogers, Chair, Healthy Community Cabinet, stated that one of twelve Walk21 Toronto 2007 Walkability Roadshows was held in Sudbury in April, 2007 and was attended by approximately seventy-five people. They received information regarding the International Charter for Walking during this time and it was acknowledged that Sudbury had already taken steps towards achieving more walking by adopting the Pedestrian Charter. He indicated that the Healthy Community Cabinet recognized that the International Charter for Walking fits within one of the four pillars of a healthy community - "Active Living/Healthy Lifestyle".

Councillor Landry-Altmann presented Walk21 t-shirts to Mr. Rogers, Mr. Paul Baskcomb, Manager of Community & Strategic Planning, and Ms. Carol Coffyn, Sudbury & District Health Unit, who have been actively involved with this issue.

Rules of Procedure

AND WHEREAS the Council for the City of Greater Sudbury endorsed the Municipal Pedestrian Charter on June 28th, 2006 as prepared by the Sudbury Heart Health Coalition, and that it be utilized as a guideline in the planning and development of walking opportunities within the City of Greater Sudbury;

AND WHEREAS the World Health Organization identifies that physical inactivity is not merely about individual behaviour, and recommends that local governments and municipalities act by developing local legislation and policy to support physical activity;

AND WHEREAS the Official Plan adopted in June of 2006 identifies active transportation and a pedestrian and bicycle network as an element of the Sudbury transportation system, and recommends protecting and expanding the existing pedestrian and bicycle network in the City as essential to creating quality of place;

AND WHEREAS the Official Plan identifies that sidewalks, bike lanes, bike paths and walking trails need to be fully integrated components of the overall transportation system, providing safe access for pedestrians and cyclists supported by good urban design principles, and that opportunities to engage in recreational and leisure activities are also tied to the transportation network;

AND WHEREAS The Greater Sudbury Community Physical Activity Action Plan 2005-2010 recognizes the need to remove and reduce barriers to physical activity by improving infrastructure in order to support pedestrians;

AND WHEREAS on January 10th, 2007, the City of Greater Sudbury was designated as a United Nations Regional Centre of Expertise for sustainable development;

Mr. Bill Lautenbach, Director of Planning Services, gave an electronic presentation which provided a review of current practices and procedures within Planning Services.

He outlined the new requirements in Bill 51 which provide for 30 days to determine if the application is complete and 15 days to inform the public by Public Notice once the application is complete. Bill 51 also regulates the required information in applications which must be provided to the public. He advised that the City's practice with respect to advising the public is to provide newspaper notice and written notice to property owners within 120 metres with Councillor receiving notice of applications in their ward early in the process. He advised that public notice requirements have increased to two public notices; one when the application is completed and one for the public hearing.

Mr. Lautenbach stated that a survey was carried out of seventeen communities across Ontario compatible to Greater Sudbury and the results were included in the Planning Committee report dated March 30, 2007 from the General Manager of Growth & Development. Several staff recommendations were provided such as 12 days availability of the Agenda, two meeting procedure for complex applications, that the new procedures be reviewed after one year to assess effectiveness and the need for revisions, etc.

Councillor Gasparini suggested that the Planning process be provided to the communities through the Community Action Networks (CANs).

AND WHEREAS improvements to Highway 17 would enhance the regional economy and public safety in Northern Ontario;

AND WHEREAS the implementation of Bill 149 is conditional on a cost-sharing agreement being entered into between the Government of Ontario and the Government of Canada:

AND WHEREAS the Federal Trans Canada Highway Act of 1949 stated that the Federal government would reimburse the provinces for 50% of the costs for any portion of the Trans Canada built after 1928 and mandated that the Government of Canada would pay 50% of future costs;

AND WHEREAS Federal Government funding for the Trans Canada Highway 17 is substantially lower than historic levels;

Item R-1 Bill 149 - Highway 17 Improvements (continued)

AND WHEREAS the Trans Canada Highway 17 in Northern Ontario, part of our national link, has the lowest percentage (10%) of fourlaned highway when compared to other provinces in Canada;

AND WHEREAS there are 488 accidents, 839 personal injuries and 31 fatalities on average each year on the Trans Canada Highway between the Manitoba border and the Quebec border;

AND WHEREAS more than 340,000 commercial trips are taken annually on Highway 17, carrying over \$19 billion worth of mining, forestry, and other goods important to the Northern Ontario economy;

AND WHEREAS the Ontario Minister of Transportation and the Ontario Minister of Public Infrastructure Renewal have both indicated that they are prepared to enter into discussions with their federal counterparts on Bill 149;

AND WHEREAS Bill 149 has the support of the Canadian Automobile Association, the Ontario Trucking Association, the Ontario Provincial Police Association, the Ontario Road Builders Association and the Ontario Safety League;

THEREFORE BE IT RESOLVED THAT the Council of the City of Greater Sudbury endorses Bill 149 and urges the House of Commons Canada and the Legislative Assembly of Ontario to support Bill 149;

AND BE IT FURTHER RESOLVED THAT the Council of the City of Greater Sudbury urges the Federal Government to participate in discussions with the Provincial Government to develop a highway improvement plan and provide 50% of the funding required to upgrade the Highway 17 portion of the Trans Canada Highway throughout Northern Ontario;

AND BE IT FURTHER RESOLVED THAT a copy of this motion be forwarded to the Association of Municipalities of Ontario and to the Federation of Northern Ontario Municipalities.

CIVIC PETITIONS

Letters of Objection Rezoning Application Reddi-Vend Ltd. Councillor Landry-Altmann submitted a petition to the City Clerk signed by approximately twenty-six (26) residents of Morin Avenue area, which will be forwarded to the Planning Committee. The petition is objecting to the rezoning application for 391 and 395 Morin Avenue, Sudbury - Reddi-Vend Ltd.

QUESTION PERIOD

Lead in Municipal Drinking Water Letter dated May 23, 2007 from the Acting General Manager of Infrastructure regarding Lead in Municipal Drinking Water Systems was tabled.

The Acting General Manager of Infrastructure advised that the levels of lead in all drinking water leaving the municipal water treatment systems is virtually zero. He advised that the City meets or exceeds all provincial drinking water standards related to lead.

He went on to explain that private property owners who encountered lead pipes were advised and recommended to replace them and that in 1997 the Regional Municipality of Sudbury introduced a corrosion inhibitor in the Sudbury Distribution System (Wanapitei, David Street, Markstay, Coniston, western half of Garson). This inhibitor significantly reduces the absorption of lead from the pipes into the water supply and significantly reduces the chances that lead would impact the drinking water. He also advised that the inhibitors are also part of the water treatment process in the Capreol and Vermillion systems and the City will be extending the use of the corrosion inhibitor to the remaining water systems in a prioritized manner.

Mr. Clausen advised that a fact sheet will be prepared in order to educate the public on the impact of lead within their private water systems which will be made available at all Citizen Service Centres and the City's website.

He advised that the City had not yet received an order from the Province of Ontario to test for lead in the City's households but the Ministry of the Environment is expected to issue an order to sixty-six municipalities to carry out testing of water for lead. Staff will inform Council if an order is received.

Affordable Housing Program Councillor Dutrisac asked the General Manager of Community Development what the status was regarding the RFP for the Affordable Housing under the Canada-Ontario Affordable Housing Program.

Affordable Housing Program (continued)

Ms. Matheson advised that the RFP will be re-issued at the end of June 2007 which will allow both private and non-profit proponents, who are interested in creating new affordable rental units in Sudbury. The amount of funding, both from the Affordable Housing Program (AHP) and the Delivering Opportunities for Ontario Renters (DOOR) Program has been increased to \$45-\$75,000 per unit.

Open Pit Burning

Councillor Dutrisac has received numerous complaints regarding open pit burning and the various materials being burned, especially in laneways.

The Deputy Fire Chief advised that staff will review the by-law regarding burning in the rural areas versus urban areas. He stated that there are many regulations on the type of materials that can be burned on private properties, the time of burning, and the location of a fire pit, but burning on property that does not belong to you has been an issue. He also advised that staff has received repeat complaints regarding pit fires.

Councillor Dutrisac stated that drugs and alcohol are an issue at the pit fires and asked Chief Davidson to comment.

Chief Davidson advised that "pit parties" are an issue and police officers have laid charges. He indicated that he will meet with Members of Council to discuss individual complaints and will advise the Officers on duty in the area affected.

Meagan McGrath

Councillor Dupuis requested that staff look at organizing a "Meagan McGrath Day" to celebrate her amazing accomplishments.

Liability Insurance for Volunteers

Councillor Berthiaume asked the City Solicitor if there was liability insurance available for the volunteers working on the CANs.

Mr. Swiddle advised that the issue of liability for volunteers comes up in several contexts for the City and that the Risk Management/Insurance Officer is reviewing this matter.

Petition - Lamothe Street and Barrydowne Road

Councillor Landry-Altmann asked what the status was regarding the petition for pedestrian lights to be installed at Lamothe Street and Barrydowne Road.

The Acting General Manager of Infrastructure advised that the traffic study will be ready by the end of June.

Security at Courthouse

Councillor Craig indicated that due to provincial downloading, the Greater Sudbury Police Services is responsible for providing security at local courthouses, which is paid by the municipality and asked Chief Davidson to comment.
