### Water/Wastewater Presentation

Mr. Nick Benkovich, Director of Water/Wastewater Services, provided an electronic presentation entitled "Proposed 2007 Water/Wastewater Budget".

Mr. Benkovich discussed water rate increases for the last five years, 2005 operating costs for the treatment and distribution of water, 2005 cost of wastewater collection, treatment and disposal, and the 2006 water/wastewater budget allocations.

He stated that there have been water/wastewater upgrades to numerous systems throughout the City of Greater Sudbury (Capreol, Valley East, Dowling, Levack, Azilda, etc.). He also outlined cost control programs that have been successfully implemented (non-revenue water, energy retrofits, remote monitoring) and cost control measures taken (water efficiency, smart meters, wastewater inflow/infiltration reduction). Mr. Benkovich stated that the Water/Wastewater Master Plan is another way to control costs.

He indicated that the deteriorated infrastructure is historically undervalued, is an inherited legacy and a deficit. He also indicated that in 2001, Council implemented the Sustainable Capital Asset Management Plan (SCAMP) which enhances the Capital Renewal annually. He advised that SCAMP provided a \$4.4 million start in reinvesting in the City's infrastructure.

Water/Wastewater Presentation (continued) He stated that the proposed 2007 water/wastewater rate increase of 4.5% is well below the Ontario median for 2007.

Ms. Lorella Hayes, CFO/Treasurer, advised that the water/wastewater budget for 2007 is \$50.1 million compared to the 2006 budget of \$48.3 million. She provided information regarding the average consumption of water for the last three years and the three components to the water/wastewater bills. Ms. Hayes also provided the major factors contributing to the water rate increase for 2007. She also explained that the fixed rate charges would increase by 4.4%, which is consistent with the water rate increase.

Ms. Hayes explained that the wastewater rate is calculated as a percentage of the water bill. For 2007, the amount that is to be recovered through billings is \$24.4 million, which is 115% of water revenue to be collected, which represents a 4.5% increase. She stated that a typical residential property owner who consumes 360 cubic meters of water per year would pay an extra \$43 per year.

Mr. Benkovich provided four enhancement options for the Committee's consideration:

Option 4	Four Fire Hydrants (Council referral)	\$ 60,000
