PUBLIC HEARING - WATER AND WASTEWATER POLICY AND CHARGES

Item 2 Introductory Remarks The Chair opened the meeting welcoming the twenty-five (25) people in attendance and advised that the public meeting was being held in accordance with the Municipal Act and Ontario Regulation 244/02 in order to receive public input on the proposed water and wastewater rate increases for 2005.

She stated that in accordance with the City's Water and Wastewater Rates Policy, these rates must be sufficient to recover the costs of providing water and wastewater services. The estimated rates to ensure these services are self-sustaining have been established for 2005.

She advised that notice was hereby given that the City of Greater Sudbury intends to pass a by-law on January 13, 2005 increasing the water rates and related water charges by 7.7% over the 2004 rates; and charging 116% (effectively a 8.7% increase) of the water bill for wastewater services.

Item 3 Presentation - 2005 Water/Wastewater Rates and Charges The Chair then stated that any person in attendance would be provided an opportunity to make representation after Items 3 and 4 on the Agenda.

An electronic presentation was presented to the Committee by Mr. Oscar Poloni, Partner, KPMG, Mr. Armand Therrien, Manager, R.V. Anderson Associates Limited and Mr. Tom Eyre, P.Eng., Management Consultant, R.V. Anderson Associates Limited. The presentation outlined the following:

- Why water rates have increased since 2001.
- How the City of Greater Sudbury compares to other municipalities.
- How water rates are projected to change in the future.

Public Hearing W/WW Rates & Charges

Mr. Ron McDonald Spokesperson, Greater Sudbury Municipal Watch Report dated 2005-01-07, with attachments, from the Executive Director of Administrative Support Services regarding Public Notification Procedures for Public Meeting - 2005 Water/Wastewater Rates was received for information only.

A "Speakers' List" was available and submissions were heard in the order that they appeared.

Mr. McDonald stated that it was important for Council to propose a plan of action that would follow through with a critical examination of how the City intends to address longstanding and serious losses of water in the system.

He stated that a 1999 Ontario Water Works Association report recorded an escapement of 44% in the Sudbury water system, which is paid for by consumers, and feels taxpayers are entitled to know what the City intends to do regarding this matter.

Mr. McDonald advised that young families with low incomes or seniors on a fixed income cannot afford to support these large increases. He stated that ratepayers are "confounded by the double-edged sword" whereby if they conserve water to reduce consumption, they are faced with higher rates to achieve budget projections.

He advised that "Council must review the water and wastewater systems to attain cost reductions and improved efficiencies through new technological processes and equipment".

Mr. McDonald also stated that the merging of City departments with Greater Sudbury Utilities, such as Human Resources, should be reconsidered.

Mr. James Waddell Citizen

Mr. Waddell stated that his concerns address all utilities and associated rate increases. It was his opinion that all governments are in the service charge business rather than the service delivery business.

He stated that Council must find where the true costs are. He also stated that 4% of the rate increase is related to administration costs which is a variable that must be looked at to find savings.

Mr. Waddell suggested to the Committee to look at tendering the buying of products, such as chlorine, or sharing costs with other municipalities and buy products by bulk.

Mr. Robert Renaud Citizen

Mr. Renaud stated that he owns an apartment building in Copper Cliff and that his water and wastewater bills have doubled but cannot raise his rents to reflect these increases due to government regulations.

He suggested that the City install flow meters in homes to monitor what is being released into the sewer system and charge individual homes accordingly.

The 'Speakers' List' now complete, the Chair asked if there was anyone present who wished to address the Committee.

Mr. José Blanco

Mr. Blanco commended Council for adopting the Capital Asset Management Program. He addressed cost savings, the increases in expenditures, the mandated increases, monitoring of water flowing from homes, and how the cost on unit bases are misleading.

Mr. Simon Nickson

Mr. Nickson stated that in 2002 he and his family moved from Montreal and is currently a homeowner in Sudbury. He noted that his first year in Sudbury they paid an additional \$556 on their water bill for the watering of sod, whereby, they learned very quickly to conserve water. He stated that their water bill in Sudbury is more than three times the charges they paid in Montreal.

What he does not understand is why taxpayers are paying for water that is not going into the system, such as the watering of lawns.

He asked if staff has looked at efficiencies to reduce costs and lower rates and stated that taxpayers are being priced out of their homes.

There were no other persons present to address the Committee.

Bradley: That By-Law 2005-24F, "BEING A BY-LAW OF THE CITY OF GREATER SUDBURY TO ESTABLISH A WATER AND WASTEWATER POLICY AND WATER AND WASTEWATER RATES AND CHARGES" be enacted by Council.

The Committee discussed the issue of efficiencies and cost savings, the conservation of water when this forces rate increases, and developing a process to look at ways to decrease rates and also look at why rates are increasing.

The Director of Engineering Services was asked to verify what the percentage was regarding the escapement of water from the system.

With the concurrence of the Committee, the General Manager of Infrastructure & Emergency Services was directed to report back to the Priorities Committee with a report outlining a plan of action to address cost reductions and efficiencies regarding the water and wastewater systems.
