Ms. McGrath indicated that she is the first Canadian Forces member and Sudburian attempting to climb Mount Everest and to achieve the seven summits. She provided a personal biography of herself and stated that the seven summits are the highest mountains on each of

the seven Continents throughout the world.

She has completed six of the seven summits and will be attempting Mount Everest between April 1, 2007 to June 10, 2007.

WHEREAS Meagan McGrath is a proud Sudbury native whose sense of adventure is rooted in her Sudbury upbringing;

AND WHEREAS Meagan will attempt to reach her seventh (7th) and the world's highest summit, Mount Everest in April/May 2007 and may become the first Sudburian to achieve this accomplishment;

THEREFORE BE IT RESOLVED THAT the Council and citizens of the City of Greater Sudbury recognize Meagan McGrath for her mountain climbing success, and wish her all the best for a safe and successful climb on Mount Everest.

Item 2 New Municipal Act

Report dated 2007-01-18 from the Executive Director of Administrative Services regarding New Municipal Act was received for information only.

Ms. Salter, Deputy City Solicitor, provided an electronic presentation entitled "The Municipal Statute Law Amendment Act, 2006 (Bill 130)".

She indicated that the Ministry of Municipal Affairs & Housing began their review of the Municipal Act, 2001 in June 2004 and on January 1, 2007, the amendments to the Municipal Act, 2001 were proclaimed in force.

Ms. Salter provided a breakdown and brief descriptions of new and changed sections of the Act in the following categories:

- Analysis
- · Limits on Broad Powers
- Governance
- Role of the Head of Council

Ms. Salter indicated that municipal governments have been given more independence by the Province which is a more mature outlook on the roles and responsibilities of this level of government.

She noted that these changes will "ensure the accountability and transparency of the operations of the municipality, including the activities of senior management". She also indicated that Council meetings may be closed, but the "resolution must state the general nature of the matter to be considered" and the Clerk "shall make a record of all resolutions, decisions and other proceedings at the meeting".

Ms. Salter also indicated that "persons may request an investigation of whether a municipality or local board (except Police Service Board and library boards) have complied with open meeting requirements in respect of a meeting that was closed to the public". She pointed out that the investigation would be conducted by an independent investigator appointed by the municipality or the provincial Ombudsman.

She concluded that this new Act is more flexible and provides a modern purposive approach. There has been considerable streamlining accomplished and the Act provides important enhancements to municipal authority. The next steps are to have detailed staff reviews and recommendations to implement required changes in policies and practices, and staff will require Council direction on optional matters.
