COUNCILLOR BRIEFING SESSIONS

LEGACY PROJECTS PROGRESS REPORTS

Introductory Remarks

Mayor Rodriquez addressed the Committee to provide context for the presentations examining the potential for a Performing Arts Centre and Multi-use Recreational Centre. At a special meeting of Council in January, they discussed priorities and identified the development of a Multi-sports Recreational Complex and a modern Performing Arts Centre as the centerpiece for what they see Greater Sudbury becoming over the next ten years. In February the two advisory panels were created and came back to Council in July with interim reports. Tonight they are here to provide more detailed reports.

Final Report -Performing Arts Centre Advisory Panel Report dated 2007-11-01, with attachments, was received from the General Manager of Growth & Development regarding Final Report-Performing Arts Centre Advisory Panel.

Diane Salo, Chair, and Dennis Castellan, Member, Performing Arts Centre Advisory Panel, made an electronic presentation regarding the final report of the Performing Arts Centre Advisory Panel.

Diane Salo listed the member of the Panel. She outlined what should be built - an economically viable multi-faceted theatre complex with 1,800 seats.

Dennis Castellan stated that the Performing Arts Centre concept is based on notions of cultural legacy, a 'district concept, which will attract partners and a multi-faceted model.

Diane Salo indicated that a downtown location is the right location, it is supported by stakeholders and the City's Official Plan and the City's arts and cultural strategy. She stated the cost of the proposed development is \$75 million from land acquisition to opening night. She stated that the next steps are to prepare a detailed business plan including resources from traditional and non-traditional revenue sources and there is a need to involve every area of the City of Greater Sudbury.

Recreational Complex Advisory Panel's Vision for a Multi-Use Recreational Complex in the City of Greater Sudbury

Report dated 2007-11-01, with attachments, was received from the General Manager of Community Development regarding Recreational Complex Advisory Panel's Vision for a Multi-Use Recreational Complex in the City of Greater Sudbury.

Cory McPhee made an electronic presentations regarding the Advisory Panel's vision for a multi-use recreational complex. He listed the members of the Panel. He explained the community consultation process and the key themes resulting therefrom. He detailed the different components of the facility. He outlined the next steps including the investigation of potential sites, capital financing plan and analysis of the impact of a new facility on existing recreational facilities. He indicated there is a need and demand for such a facility because of the aging infrastructure of existing facilities and the lack of a tournament and special events centre. He outlined the benefits to the community of the proposed facility such enhancing quality of life and community image and sports tourism. He requested continuing support, ongoing participation, and expertise and guidance from Council and the community.

Closing Remarks

Mayor Rodriguez stated that the decision to be made tonight is not whether or not to commit funds to these facilities. It is whether or not to fully investigate their potential and develop a financial package to allow the projects to go forward.
