request receipt of an approved Residential Inflow & Infiltration Subsidy under the City of Greater Sudbury's Residential Inflow & Infiltration Subsidy Program and certify as to the following:

- I will obtain and submit at least two quotes from licensed plumbing contractors for the installation of a sump pump/pit and approved backwater valve.
- I understand that payment for the subsidy will not be granted for the installation of rain barrels and/or eavestrough extenders (maximum of four) until 90 days after purchase.
- I will obtain and submit at least one quote from a licensed contractor for the service of lining the private sanitary sewer lateral line
- I will agree to site visit by a representative of Greater Sudbury's Water/Wastewater Services.
- The property taxes for the property are up-to-date and paid in full.
- Eavestrough downspouts, sump pumps and weeping tiles located on the property are not connected to the municipal sanitary sewer system OR,
 - eavestrough, sump pump and/or weeping tile are connected to the municipal sanitary sewer system and a written opinion provided by a licensed plumber and/or contractor will be obtained and submitted to the City of Greater Sudbury.
- I understand that a plumbing or building permit is required prior to the installation of a sump pump/pit, an approved backwater valve and/or a sanitary sewer lateral lining and that an inspection by an official of Building Services is required after installation.
- I understand that I am not guaranteed a Residential Inflow & Infiltration Subsidy until I receive a letter from the City of Greater Sudbury confirming my eligibility and the amount.

I/We understand that:

- (a) If I install a sump pit drainage system, I must ensure:
 - (i) My yard has a positive slope (ii) I am responsible if collected water impacts other properties
- (b) If I install a backwater valve, a sump drainage system must be installed, and the backwater valve needs to be:
 - (1) Accessible for maintenance
 - (2) Maintained in good working order – an annual maintenance plan is advisable and
 - (3) Protected from damage including damage from freezing
- (c) The Subsidy program allows for the installation of: an approved backwater valve, a sump pit/pump, a maximum of 2 rain barrels, a maximum of 4 eavestrough extenders, a sewer lateral lining or a combination of the above. The property owner has six months to complete the installation and to submit all required paperwork, following receipt of a letter confirming the Residential Inflow & Infiltration Subsidy. Failure to meet the six month deadline will forfeit approval of the subsidy.

I/We understand and agree that the subsidy provided by the City is not a recommendation by the City that the work subsidized should be undertaken or a representation that the work undertaken will prevent any future flooding or sewer backups. I/We have satisfied ourselves on all matters regarding to the work.

The City, its elected and non-elected officials, employees and agents will not be liable to the recipient or recipients of the subsidy funding, their contractors, any person affected by the work done to obtain a subsidy, or any other person, for Claims however caused that arise out of or are in any way related to the subsidy, the Subsidy Program or work done for which a subsidy is available or made.

I/We hereby agree(s) to indemnify and hold harmless the City, its elected and non-elected officials and employees from and against any and all liability, loss, costs, damages and expenses, (including legal fees), causes of action, claims, demands, lawsuits or their proceedings by whoever made, sustained, incurred, brought or prosecuted, in any way arising out of or in connection with the Subsidy Program or work done for which a subsidy is available or made.
